

Minnesota Post Election Voting System Review - 2006

The Post Election Review of Voting Systems is mandated for the election for president or governor; United States Senator and United States Representative after each state general election beginning in 2006. This review is a comparison of a hand tally of the ballots for each eligible election in the precinct with the reported results as per the county canvassing board report.

1. The time, date, and place of the voting systems review is set by each county at its county canvass of the September 12 state primary election.
2. Individual precincts that will be reviewed are selected by each county at its county canvass of the November 7 state general election.
